Pip (no 85) has agreed to take over this important job (with your support) and so **we need other volunteers to keep the Committee at reasonable strength to help the WPRA carry out its remit to look after the woods and walls on behalf of all WP proprietors.**

Although we have had some projects to fund this year there is likely to be **no increase** in the modest fee level of £30 due on 1st October each year – this is £2.50 per month, a fraction of what the charge would be from a commercial factor but is dependent on continued voluntary work from Committee members.
